Annual progress review of PhD students 2023 – 2024

The progress of **1st year PhD** candidates **(enrolled during the academic year 2023-24)** will be evaluated by means of:

- ✤ A report/questionnaire by the student's doctoral supervisor(s).
- ✤ A questionnaire by the student.
- A 15 minutes (maximum) oral presentation (in Catalan, English or Spanish) to the evaluation committee, followed by a 15 min discussion with the commission.
 - Oral presentation outline:
 - General presentation of the research plan: basis of the research (briefly), objectives, resources available (material, infrastructures, financial support). **No results required.**
 - Research planning: for the 4 years being more specific for the first year (accomplished) and second year.
 - Training activities planning (for the whole PhD)
- All docs (questionnaires and presentation) <u>must be sent to doctorat.icta@uab.cat</u> two weeks before the evaluation.
- The objective of the evaluation is to check how the thesis is developing according to the research plan and planning of any contingencies.
- If any modifications are suggested by the evaluation commission to the Research Plan or Activities Plan, the changes must be discussed by the student with the supervisors and (when applicable) documents updated.
- The evaluations will be on July 2th, 2024, according to the schedule proposed by ICTA unless stated bellow for a specific research area.
- The evaluations will not be open sessions and will only be attended by the evaluators and the student.
- Each research area has its own evaluation commission. The research areas are:
 - Ecological Economics and Environmental Management
 - Environmental Technology
 - Global Change and Climatic Change
 - Industrial Ecology

The progress of 2nd year PhD candidates (enrolled during the academic year 2022-2023) will be evaluated by means of:

- ✤ A report/questionnaire by the student's doctoral supervisor(s).
- ✤ A questionnaire by the student.
- Evidence of the submission of a paper to an international peer-reviewed indexed journal, derived from his/her doctoral research to date.
- An oral presentation (10 min maximum) (in Catalan, English or Spanish), which must contain the following sections:
 - Objectives and achievement.
 - Research planning: what has been done and what remains. Specific planning for the 3rd year (highlight changes respect to the original plan).
 - Training activities: activities already done and future activities planning.
- All docs (questionnaires and presentation) <u>must be sent to doctorat.icta@uab.cat</u> two weeks before the evaluation.
- The main objective of the evaluation is for the committee to detect any dysfunction during the development of the PhD research plan that may place in jeopardy the completion of the project within 3 years.
- If the PhD project is developing according to the research plan, and a paper has been submitted, the committee can assume that the PhD project is on track.
- The evaluations will not be open sessions and will only be attended by the evaluators and the student.
- The evaluations will be arranged on July 3th, 2024, according to the schedule proposed by ICTA unless stated bellow for a specific research area.

 - Publications derived from the PhD thesis.
 - Training activities: activities already done, and activities planned.
 - A tentative date/month for thesis deposit.
 - If needed, a justification of why an extended period is required to complete the thesis, and contingency planning to do so (an extension request must have been presented).
- All docs (questionnaires and presentation) <u>must be sent to doctorat.icta@uab.cat</u> one week before the evaluation.
- The main objective of the evaluation is for the committee to ensure that the project will be completed in the following year.
- The evaluations will not be open sessions and will only be attended by the evaluators and the student.
- The evaluations will be arranged on September 17th, 2024, according to the schedule proposed by ICTA.

The thesis progress of 4th (enrolled during academic course 2020 - 2021) and 5th year PhD candidates (enrolled during academic course 2019 – 2020 or before), and that do not deposit the thesis before September 30th, 2024) will be evaluated by means of

- ✤ A report/questionnaire by the student's doctoral supervisor(s). If needed, the requirement for an extended period must be endorsed.
- ✤ A questionnaire by the student.
- An oral presentation (10 min) (in Catalan, English or Spanish), which must describe:
 - Objectives and achievement (include training activities if any left).
 - Publications derived from the PhD thesis.
 - A tentative date/month for thesis deposit
 - If needed, a justification of why an extended period is required to complete the thesis, and contingency planning to do so (an extension request must have been presented).
- All docs (questionnaires and presentation) <u>must be sent to doctorat.icta@uab.cat</u> one week before the evaluation.
- The main objective of the evaluation is to show that a plan is in place to complete the thesis in the shortest time possible and by the 5th year.
- The evaluations will not be open sessions and will only be attended by the evaluators and the student.
- The evaluations will be arranged for September 18th, 2024, according to the schedule proposed by ICTA.
